Publication Ethics

European Journal of Marketing and Economics (EJME) is committed to upholding the highest standards of publication ethics. To ensure the integrity, quality, and transparency of the scholarly content published in the journal, EJME follows the guidelines and principles outlined below:

1. Article Assessment

All submitted manuscripts undergo a rigorous peer-review process conducted by experts in the field. The review process is impartial, objective, and confidential, and it evaluates the scientific validity, originality, and significance of the research. Reviewers are selected based on their expertise and are expected to provide constructive and unbiased feedback to authors.

2. Duplicate Article

EJME prohibits the submission of manuscripts that contain substantial similarities to previously published works, including self-plagiarism. Authors must ensure that their submissions are original and have not been published or submitted elsewhere concurrently.

3. Data Fabrication and Falsification

EJME employs plagiarism detection tools and verifies the originality of submitted manuscripts. Authors must properly cite and reference all sources used in their research, including their own previously published work.

5. Authorship

EJME adheres to the principles of authorship outlined by international guidelines, such as the International Committee of Medical Journal Editors (ICMJE) recommendations. Authors must meet the criteria for authorship, which includes making a substantial contribution to the research, participating in the drafting and revision of the manuscript, and approving the final version. research should be acknowledged as contributors or mentioned in the acknowledgments section.

6. COPE
